



FLORIDA LEGISLATOR SCORECARD

INTRODUCTION:

This resource equips Florida voters to evaluate whether State Representatives and Senators running for reelection have upheld principles of faith, parental rights, individual liberty, and government transparency. This tool offers a combination of research guidance, and a detailed scorecard designed to assess elected officials based on public records and official actions.

PART I – RESEARCH AND VETTING RESOURCES:

This section provides a curated list of credible sources to help you examine a candidate's public record, voting history, campaign finance activity, affiliations, and public statements. These tools are designed to support informed, objective evaluations based on verifiable information rather than campaign rhetoric or third-party commentary.

- Look up bills sponsored, voting records, and member profiles on Florida House and Senate websites myfloridahouse.gov and flsenate.gov
- Search campaign finance reports, candidate filings, and prior elections on State DOE website: dos.myflorida.com/elections
- Use local [Supervisor of Elections websites](#) to look up past party registration history, voting districts, and local candidate filings
- View detailed breakdowns of campaign contributions, top donors, and political spending on TransparencyUSA.org/FL
- Check if a candidate is tied to businesses, LLCs, or PACs at sunbiz.org or OpenSecrets.org
- Use openstates.org for user-friendly bill tracking and legislator profiles
- Find candidate bios, endorsements, and issue positions on Ballotpedia.org
- Use local government or official websites to review meeting minutes, commission agendas, and voting records for insight into local decisions
- Watch recorded school board or commission meetings when available
- Review candidate social media & official campaign sites
- Look at public statements, videos, articles and interviews

The scorecard offers a structured framework to assess where a candidate stands on issues of importance to Florida families. Each question should be answered using publicly available records, or direct candidate responses.

The final score offers a summarized interpretation of a candidate's alignment with the values represented in this resource.

HOW TO USE THIS SCORECARD:

- Answer each question based on public records, voting history, public statements, or affiliations
- For each question, mark: YES, INCONSISTENT, or NO
- Add up the totals for each section and calculate a final score out of 100
- Use the interpretation key to understand what the score means
